The evidence from the Annual Performance report of Lwengo DLG on page 10 showed that 2 valley tanks (capacity 3,000 m3) were constructed, 1 mini solar powered borehole scheme was built, 2 brick masonry tanks (capacity 30 m3) and 4 (capacity 50 m3) tanks were built, 1 water borne public toilet and 1 public latrine were constructed, 1 deep borehole was drilled but was dry, one piped water supply system was extended and six deep boreholes were rehabilitated. From the field visit made by the assessor on 15th November, 2022, the following were observed:

• The 5-stance public toilet was built at the head office and is functioning well. Its water supply is derived from the underground reservoir of the DLG.

• St. Paul Kyamukuzi Secondary School rain water harvesting tank was completed and is being used by the students. There was a rubbish pit very close to this tank which could undermine the integrity of the foundations of the tank and cause it to crack. The head Teacher was advised to backfill and compact this pit for the safety of the water source.

 Kibuye village mini solar powered borehole scheme was completed and found under use by the community who make a monthly contribution of Ugx. 1,000 per household. The care taker who doubles as the chairman WSC said the WSC had been trained and he also showed a good recollection of the responsibilities taught in the training. He was advised to keep the entire area clean of rubbish, wild grass and ponding water.

Reporting and performance improvement: The LG compiles, updates WSS information and supports LLGs to improve their performance

This showed that the DWO collected and compiled information on sub county water supply and sanitation, functionality of facilities and WSCs and community involvement, albeit not on quarterly basis.

There was a rubbish pit very close to the tank which was instructed to be filled and compacted to ensure ground stability for the heavy tank. The students accessed the water from a tap in a manhole. The manhole was built too small and the students have to fetch the water while bending down. This issue arose from error in the design.

The mini solar powered water scheme of Kibuye village was built according to the design which included a submersible water pump, pump control house on top of which four solar panels are fixed, elevated reservoir on a steel structure and four water dispensing taps. The entire set up was fenced and operational.
